# Red Flags to Watch For

- **No Experience in Regulated Markets:** Vendors who haven't worked with MGA, UKGC, or Curacao licensing may overlook critical compliance requirements.
- **Missing SLA or Post-Launch Support Terms:** Absence of defined service-level agreements often leads to unresolved issues and downtime.
- **No Ownership of Code or IP:** If the vendor retains source code rights, you may face legal and business restrictions in the future.
- **Limited Integration Capabilities:** Closed platforms with no third-party API support reduce flexibility for KYC, CRM, analytics, and affiliate tools.
- **Unrealistic Delivery Commitments:** Promising complex builds in 3–4 weeks without proper roadmaps is a sign of inexperience or shortcuts.
- **Unbranded or Template-Based UI:** Using generic designs can weaken brand identity and reduce user retention over time.

- **RNG Certification**

Accredited randomness engines (GLI, iTech Labs) for fair gameplay.

- **Data Protection Standards**

GDPR and ISO 27001-compliant infrastructure for global data security.

- **Player Safety Features**

Age verification, geo-blocking, and responsible gaming modules.

- **AML/KYC Integration**

Secure onboarding via tools like Jumio, ShuftiPro, or custom APIs.

- **Wallet Security**

Encrypted vaults for both crypto and fiat transactions.

- **Audit Trails**

Comprehensive logging of backend actions for compliance and transparency.

- **Fraud Prevention**

Real-time session monitoring, anomaly detection, and anti-fraud filters.
